**Title:** Poison Prevention Training for Adults

**Training Goal:** To educate day care providers about the danger of potential poison exposure in their environments, and how to prevent and appropriately respond to accidental poisonings.

**Learning Objective(s):** Participants will:


- Identify potential poisonous items and substances in their everyday environment
- Describe strategies to prevent accidental poison exposures
- Observe proper safekeeping of medications in the child care environment
- Review First Aid for accidental poisoning
- Verbalize information needed when contacting poison control call center

Introduction of common toxic substances, routes of exposure, and prevalence of accidental poisonings to children	Lecture / power point	30
Review prohibited substances, need for Material Safety Data Sheets (MSDS).	Lecture / power point	30*
Review individual toxic substances: Radon, Carbon Monoxide (CO2), Lead, Plants, Chromated Copper Arsenate(CCA) treated wood, arts and crafts material, common household items	Lecture / power point	20
Seasonal and Holiday items of concern	Lecture / power point	20*
Reducing the risk of exposure to toxic substances	Lecture	10*
Poison Control: What you need to know and toll free number	Lecture / Small group discussion	10
