Missouri has THREE NEW MCH-related Dashboards!

- PAMR (Pregnancy-Associated Mortality Review Dashboard):
 https://health.mo.gov/data/pamr/dashboard.php; provides
 data related to pregnancy-associated deaths by county, along with additional pregnancy related data.
- Newborn Hearing: https://health.mo.gov/living/families/genetics/newbornhearing/dashboard-ehdi.php; provides data related to early hearing detection and interventions in Missouri.
- PRAMS (Missouri Pregnancy Risk Assessment Monitoring System): https://health.mo.gov/data/prams/prams-dashboard.php; provides data on a variety of topic areas, including but not limited to pregnancy intention, folic acid consumption, contraceptive use, health insurance, prenatal care, breastfeeding, infant health care, alcohol and tobacco use, violence against women, and postpartum depression.

Show-Me ECHO (Extension for Community Healthcare Outcomes) coordinates learning sessions that offer free continuing education. 89% of learners indicate changes to practice.

Show-Me ECHO is a state-funded telehealth project operated by the Missouri Telehealth Network at the University Of Missouri School Of Medicine. Videoconferencing is utilized to connect interdisciplinary teams of experts with

healthcare professionals to provide a learning experience to advance skills and best practices. MU's ECHO program launched in 2014 to educate and train providers in specific disease states or conditions. Since that time it has grown to provide more than thirty different ECHOs related to pressing health needs, with many addressing maternal child health populations, including but not limited to: Building Healthy Communities, Show Me Strong Kids, Missouri Moms and Babies, Mother, Infants & NAS, Opioid Use Disorder, and Oral Health.

I see MOPHIMS in the MCH Services Scope of Work- what is it?

Referencing the MCH Services Scope of Work:

6.6 The Contractor, at a minimum of twice per calendar year during the effective dates of this contract, agrees to verify which of its employees are still employed and still require partner-level access to the Department's Missouri Public Health Information Management System (MOPHIMS). The Contractor shall perform verification and updates with the MOPHIMS Program Security Officer at Division of Community and Public Health, Bureau of Health Care Analysis and Data Dissemination.

13.2 The Contractor shall use information from MOPHIMS for programmatic purposes and ensure that information is appropriately protected to ensure confidentiality.

- MOPHIMS = Missouri Public Health Information Management System
- Request partner-level access for MOPHIMS through an ASAP request
- Please mark your calendar to update users twice a year: email the MOPHIMS Program Security
 Officer at MOPHIMSUSERGROUP@health.mo.gov and in Subject Line type "MOPHIMS Access
 Updates" to notify the PSO of employees who are no longer with the LPHA and need to have
 access removed.
