Do we need to revise the MCH Services contract annual approved budget worksheet as salaries increase and/or staff come and go?

The MCH Services Program does not require the MCH Services contract annual approved budget worksheet be revised as salaries increase and/or staff come and go; rather the focus is on the overarching budget principles/parameters. Our program instead recommends that as salaries increase and/or staff changes, that you email the program with updates, and we will save the documentation on our end.

To ensure the principles of the contract are being met, referencing the MCH Services contract Scope of Work,

7.3 If the Contractor identifies specific needs within the Scope of Work, the Contractor may rebudget up to 10% of the total budget between object class categories of the budget for approved expenditures without obtaining prior written approval of the Department. This is a total of 10% across the contract for the entire year, and anything exceeding that 10% total must be approved.
